**Finance:** The £831cost of the election were discussed with the councillors stressing the need to rebuild the finances as soon as possible to cover any future election and to work towards building a larger balance. It was noted that the parish share of the D band council tax cost was £8.51in this financial year. It was further noted that it will not be possible to pay all grants fully, as budgeted, in this financial year due to the election costs.

It was proposed by Mr. Piggin and seconded by Mr. Burdett that the Precept for 2020-2021 be raised by 100% to £2,600. This was agreed unanimously by the council. It was proposed by Mr. Ames, seconded by Mr Deane and agreed by the council that the election costs of £831 be paid. Grants for this financial year will be agreed at the next meeting.

Mr. Price confirmed that there are no costs for the parish council in regard to the 2020 Police and Crime Commissioner Election. It was suggested that NNDC could revert to the system of having a list of election charges given to parishes for reference when setting the precept as the confusion over possible charges and the eventual bill for the election has made financial planning difficult.
